



1 INTRODUCTION

1.1 Purpose



3 BACKGROUND AND OBJECTIVES

3.1 Background

The purpose of this draft protocol is to inform the activities involved with planning and scheduling mosquito diversity and phenology sampling for the Field Operations Prototype. This section of the document outlines the field and laboratory procedures to collect, process, and maintain the integrity of the mosquito diversity and phenology samples.

The purpose of the Mosquito Diversity and Phenology sampling design is to capture inter- and intraannual variation of mosquitoes (Diptera: Culicidae) in the NEON purview. Mosquitoes were chosen as a focal terrestrial invertebrate taxon because they are widespread and important vectors of disease. They are also relatively easy to sample and populations are sensitive to climate variation. Mosquito species' range expansions as well as invasions of non-native species are presently occurring in North America (e.g., *Aedes albopictus*). These shifts are expected to increase with warming climates in temperate latitudes, which can impact the spread of disease.

The following sub-sections contain draft protocols that provide detailed guidance for setting mosquito traps in a subset of the Biodiversity Plots, collecting insects and associated metadata, laboratory processing of the mosquitoes, and storage and shipment of samples to contracted experts (Taxonomists) for morphological identifications, to Genetic Analytical Laboratories for DNA barcoding, and/or to Archives (voucher collections). Other invertebrates (considered "bycatch") will be preserved and grouped by collection date and shipped to Archive facilities (for the 2011 sampling year this will be the Support Facility at 1635 38th St., Suite 100, Boulder, CO 80301).

A CO_2 light trap is baited with CO_2 (carbon dioxide) (also called dry ice pellets). Carbon dioxide acts an attractant for mosquitoes as they use it as a cue for vertebrate hosts. Mosquitoes display seasonal (phenological) patterns with maximum abundances and activity periods in spring, summer and/or fall (depending on the species).

This document describes the required protocols for conducting field sampling, making a human-mediated field observation, or operating an instrument to make measurements in the field, or any other activity that generates a Level 0 data product.

7 SAFETY

8 PERSONNEL REQUIREMENTS

10.1 Sampling Frequency and Timing

There are two different sampling regimes.

Mosquito Phenology Sampling Schedule: This is two total CO₂ light traps being collected twice per week after 24 h. These traps are collected by whomever is available (field or lab technicians or domain staff) and then all collected invertebrates are shipped directly to a Taxonomist. Normally this activity would start around April 2 in Domain 10. This year, however, due to timing of hiring in 2011, the phenology sampling schedule will occur only at the end of the sampling period from Monday Aug 1 to Friday Sept 30, 2011.

This Mosquito Phenology sampling schedule is meant to be less intensive, but the data are meant to indicate seasonality of particular species and their anticipated changes over time.

Mosquito Diversity Sampling Schedule: This is ten total CO_2 light traps being collected twice per week within 24 h of trap set up in a subset of the Biodiversity Plots. These traps are to be collected by the Mosquito Diversity field crew. The field crew then sorts the samples and sends mosquitoes to a Taxonomist and the invertebrate bycatch to the Archive. The first actual sampling should occur on Monday May 16 and continue through to the week ending Friday July 29, 2011. (Training during Monday May 2 – Friday May 13)

Mosquito sampling occurs for two nights with 7 days between the first sampling day of one bout and the first sampling night of the next bout and within 3 hours of standard time each week. We estimate Diversity sampling requires 2 technicians for 12min per trap x 10 traps = 120 min = 2 hours each sampling day plus hiking time and travel to and from site. We estimate Phenology sampling requires 2 technicians for 12min = 0.5 hour each sampling day plus hiking time and travel to and from site.



10.3.4.2 Weekly Sampling Preparation

All necessary field equipment will be assembled at least one day prior to field sampling to ensure spreadsheets are uploaded or printed and that all consumables are available. The Mosquito Diversity Field Crew is responsible for transferring the appropriate files to the handheld PDA before field sampling and / or printing out appropriate datasheets. These files will include mapping tools to find the Biodiversity Plots and fields for entering GPS waypoints, metadata, and comments during sample collection.

The following must be prepared prior to field work:

- 1. Bench space (2.4 m) to spread out trap components and check all required parts.
- 2. Storage for dry ice delivered before field sampling for trapping (dry ice or CO₂pellet freezer).
- 3. Cabinet space for trap storage.
- 4. Space to store 12 batteries (12, 6 V 10 for active field work and two for backup) with overflow secondary containment bins.
- 5. Access to outlets to charge 12, 6 V batteries with overflow secondary containment.



6. Clear freezer space.

10.3.5 Sample Collection in the Field

10.3.5.1 Trap Collection

- 2. Do not switch off the fan while removing the catch cup. The fan running ensures that the mosquitoes cannot escape from the catch cup as it is being removed.
- 3. Tie off the string around the mesh part of the catch cup, ensuring that all mosquitoes are clear of the mesh that is being tied into the knot.
- 4. Place catch cup into chest cooler (with ice packs).
- 5. Record in the 'NEON Mosquito Phenology & Diversity Datasheet' the number of mosquitoes in the trap using the scale 0/1/2/3 (numbers increasing with catch size) and any other relevant information (e.g. trap damaged by wind).

If a second night of sampling is occurring:

- 1. Refill the hanging cylinder cooler about ½ full with dry ice (~1 kg).
- 2. Attach a fresh (empty) catch cup to the trap.
- 3. Pull the battery leads off and then reattach them. This resets the trap and will ensure that the



fan is off until dusk (reducing battery draw).

4. Place the battery in a large ziplock bag to keep it dry.

If sampling is complete:

• Bring in batteries and all trap components to the lab

10.3.6 Sample Preservation

10.3.10 Equipment Maintenance, Cleaning, and Storage

10.3.10.1 Battery handling

The batteries used are 6 V sealed lead acid. They pose little risk, but proper handing should be followed. Batteries must have their own charging area where they are situated in secondary containment bins. [Figure 5]

10.3.10.2 Battery charging

CARE SHOULD BE EXERCISED WHEN CHARGING A DEPLETED BATTERY as chargers become HOT and the charger case can cause burns. Chargers should not be touched until after the GREEN light comes on. Warning signs should be placed around the batteries while charging.

The sequence of connections is very important for the charger's computer.

- 1. *Connecting the charger:*
- a. Connect the color-coded leads to the battery.
- b. Plug the charger into the AC outlet. If the battery is mistakenly connected backwards (negative to positive) or charger leads are shorted together, no damage or sparks occur—only a RED light comes on to indicate the possible mistake.
- 2. Initial:



- a. When the charger is initially plugged in, the unit's computer sends intermittently, a small current into the battery and then monitors the battery's response to determine its charge state. A RED light may come on briefly if the battery was excessively discharged, but it should go off within the first few minutes.
- 3. Bulk charge mode:
- a. When the charger determines that the battery can safely take a charge, it goes into the bulk mode where the full capacity of the charger is applied to the battery until it is 80% charged. In this mode, the YELLOW light comes on.
- 4. Absorption charge mode:
- a. Once the battery is 80% charged, the computer within the charger tapers the current from 100% to 33% of charger capacity until the battery reaches full charge. The light will remain YELLOW during this phase.
- 5. Float charge:
- a. After full charge has been reached, a GREEN light comes on, indicating the battery is ready for use. The unit is now in its maintenance mode, keeping the battery in its ideal charged state. Once the battery has reached this ideal state, the charger maintains this condition. This means that batteries may be left connected to the charger overnight, over the weekend, or indefinitely, and when they are picked up, they are in the ideal state.

Estimating Battery run time:

Maximum run time for a trap may be calculated by taking 75% of the battery's AmpHr rating divided by the traps current consumption. Note: as the battery ages and undergoes charge/discharge cycles, its AmpHr capacity when fully charged declines until finally the battery must be replaced. Cool storage prolongs battery life. The trapping nights during the summer are typically 8-9 h.

CO₂ light trap use:

0.75 * 10 AmpHr / 0.25 Amps per h consumption by the trap (fan and light bulb running together) = 30 h total run time

Estimating Battery charge time:

 CO_2 light trap use for 10 h of run time:

10 h * 0.25 Amps/hour = 2.5 Amps

2.5 Amps drawn would take about 2 hours to recharge.

1.25 Amps drawn would take about 1 hour to recharge such a battery.

Battery recovery after deep discharge:

A battery that has been over-discharged requires a longer charging period than normal. PLEASE TAKE CARE TO NOT DEEP DISCHARGE THE BATTERIES. Often these batteries cannot be recharged and are not covered by the warranty. During the initial stage of charging an over-discharged battery the charger may give a false "full charge" indication, or may initiate charge at a float voltage. Quite often, once a battery has been over-discharged it cannot be recharged and must be replaced.

11.2.2 Preparation

11.2.2.1 Generating Sample Labels

[This section is a draft for the Field Operations Prototype at CPER 2011 and is TBR.]

Six different kinds of sample labels are required. Each is dealt with in turn below.

1. <u>FIELD LOCALITY LABELS</u>: Locality labels for samples should be created before the field campaign begins in order to expedite processing and reduce opportunities for error.

Laboratory technicians are responsible for generating sample labels on archival, ethanol-safe paper. A template file will be provided from FSU for locality labels to be adjusted following the procedure below.

Locality labels include particular information in order to be consistent with collection records from other global campaigns.

- State
- County
- Town
- Elevation (m)
- GPS coordinates N and W with four degrees reported in WGS84
- trap type (e.g. pitfall or CO2)
- space left for the day, the month and the year are printed (e.g. ____Aug2008)
- collectors (e.g. KKBlevins)
- a collection code which is comprised of the following parts: NEON.FSU.Domain.Plot.Trap

To prepare labels:

- a. Cut labels into long columns using an exacto knife and ruler.
- b. Do this with as little white space on either side of the text as possible.
- c. These cuts result in many labels in a vertical strip.

d. Store labels this way, and then when needed, cut individual labels across the row with scissors.

e. Add date numbers with archival, ethanol-safe ink as needed. This is a key step, as this particular information and kind of ink is required. Prompts are found throughout the protocols for each time this is required.



- 2. <u>LAB LOCALITY LABELS</u>: Storage containers for long term sample archive in voucher collections (e.g., 50 mL centrifuge tubes) will require locality labels inserted into them in triplicate (three individually cut labels).
- 3. <u>DNA BARCODE UNIQUE NUMBER LABELS</u>: A file will be provided from FSU with the reserved unique numbers for specimens that are to be DNA barcoded. These numbers are to be applied to pins below locality labels on each specimen to be DNA barcoded.
- 4. <u>TEMPORARY LABELS</u>: Consumables that only require temporary labels (e.g., waste ethanol cups, cardboard mailers) will be marked with laboratory tape and sharpie makers.
- 5. <u>MICROPLATE LABELS</u>: Ninety-six well microplates will have 'NEON#' written in sharpie on multiple sides of the plate. These numbers are in series and are to be designated by FSU.
- 6. <u>SHIPPING LABELS</u>: Shipping labels with the relevant details for addressor (Domain contact) and addressee (the external facility) should be pre-made to expedite shipping throughout the field season.

11.2.4.1 Establishing Workspace: Return from the Field

- 1. Space in -20°C freezer for killing collected invertebrates.
- 2. Clear 2.4 m lab bench for sorting purposes.
- 3. Drop down netting around lab bench to enclose space.

11.2.4.2 Euthanizing invertebrates & sorting mosquitoes from bycatch

[This section is a draft for the Field Operations Prototype at CPER 2011 and is TBR.]

- 1. Put catch cups in freezer immediately upon arrival at lab.
- 2. Leave in freezer for a minimum of 30 min (to kill all invertebrates).
- Place frozen invertebrates on a chilled surface. This can be either a foil-covered paper plate on a foil-covered ice pack or a chill table. In either case, use a piece of plain white paper on the chilled surface to assist in transferring samples into tubes. [Figure 10]



4. Drop down netting around work area. Carefully remove sample from a single trap (after ensuring all invertebrates are dead) onto chilled paper. Separate mosquitoes from other invertebrate bycatch by using a small paintbrush and/or forceps (being careful not to break off legs or other identifying parts).

11.2.4.3 Establishing Workspace: Lab work to be completed within days of collection

[This section is a draft for the Field Operations Prototype at CPER 2011 and is TBR.]

- 1. Full lab bench space (4.6 m or equivalent) in clean lab with 2 microscopes (1 dissecting and compound) connected to computer and room for one additional dissection microscope.
- 2. Lab bench space (2.4 m or equivalent) in clean lab for preparation of pinning materials.
- 3. Clean lab bench space (no dust, wild air movement) for putting tissue samples into wells for genetic analysis (to be sent to external facility).
- 4. Access to sink for rinsing equipment.
- 5. Storage space in clean lab for pinning materials.
- 6. Storage space for pinned mosquitoes.
- 7. Cold storage space for preserved specimens from Taxonomists in 25 dram tubes.
- 8. Storage space for shipping materials.

11.2.4.4 To distinguish mosquitoes from other similar-looking insects note these features

[This section is a draft for the Field Operations Prototype at CPER 2011 and is TBR.]

- 1. Antennae with 6 or more segments.
- 2. Male mosquito antennae are plumose (fluffy).
- 3. Female antennae are short-haired and appear like small wires.
- 4. Mosquitoes' wings have scales along the veins and the margins.
- 5. Mosquito mouthparts are long and tubular.

11.2.4.5 For each bycatch & mosquito sample

[This section is a draft for the Field Operations Prototype at CPER 2011 and is TBR.]

- Record in the 'NEON Mosquito Phenology & Diversity Datasheet' the size of the catch using the scale 0/1/2/3 (numbers increasing with catch size) and any additional notes (e.g. 0 specimens because a battery failed). [Figure 12]
- 2. Record in the 'NEON Mosquito Phenology & Diversity Datasheet' an estimate of number of blood fed mosquitoes in the sample (if any).
- 3. Pad the bottom of a 50 mL tube with half of a piece of facial tissue.
- 4. Place mosquitoes in the tube.
- 5. Pad the top of the 50 mL tube with another half piece of facial tissue (use extra tubes for large samples).
- 6. Place three copies of the locality label (date filled in) on top of the topmost facial tissue. [Figure 13]
- 7. Double check that the sample has correct locality label.
- 8. Follow the above steps for the invertebrate bycatch also.
- 9. Label the lid of each tube with a sharpie as either 'mosq' for mosquitoes, or 'byc' for bycatch and the collection code and date.
- 10. Secure lid.

Mosquitoes will be sent to Taxonomists for identification (see Taxonomists section for details on shipping)

11.2.1 Data Handling

11.2.2.1 Establishing Workspace: Shipping & Receiving

1. Storage space for shipping materials (50 mL centrifuge tubes, cardboard mailers, cardboard



boxes, packing tape, etc.).

2. Space for preparing packages for shipping.

11.2.2.2 Taxonomists

Sorted mosquito specimens are shipped overnight to expert Taxonomists with a hard and digital copy of the 'NEON Mosquito Phenology & Diversity Datasheet' at the end of the sampling week.

- 1. Place 50 mL mosquito catch tubes in ziplock bags.
- 2. Label ziplock bags with the collection codes and date in sharpie.
- 3. Put ziplock bags in secure location (preferably refrigerated at 4°C) to be packed and shipped with all sampling bouts from the week.
- 4. Pack ziplock bags in cardboard boxes with ample packing material to ensure specimens are not jostled. These boxes should be clearly labeled with 'Fragile' and 'Dead Insects for Scientific Study'.

11.2.2.3 Genetic Analytical Laboratories

 Ship 96 well microplates dry, overnight at room temperature (20°C) to external facilities along with a hard and digital copy of the 'NEON Mosquito Phenology & Diversity Datasheet'.

11.2.2.4 Archives

[This section is a draft for the Field Operations Prototype at CPER 2011 and is TBR.]

- 1. Archives are voucher collections of a variety of materials that represent many different kinds of storage (e.g. dry in cabinets, -80°C, specimens in ethanol). Each of these differing kinds of facilities should receive a hard and digital copy of the 'NEON Mosquito Phenology & Diversity Datasheet'.
- 2. Ship prepared dry material in cardboard mailers packed in outer boxes with ample packing material to ensure that the specimens are not jostled. These outer boxes should be clearly labeled with 'Fragile' and 'Dead Insects for Scientific Study'. Ship Genomic DNA extractions overnight to cryogenic facilities to be stored at -80°C. These facilities should aliquot and send sample location and storage parameter data to NEON. This information should be entered into the 'NEON Mosquito Phenology & Diversity Datasheet'.



11.2.3 Sample Preservation

- 1. Specimens that arrive back from the Taxonomist in 25 dram plastic cap tubes are to be optimally stored at -20°C.
- 2. Failing this, they may be stored at 4°C.

11.2.4 Laboratory Maintenance, Cleaning, Storage

- 1. Wash out CO₂ catch cups and leave on lab bench to dry on paper towels.
- 2. Make sure all catch bags are clean and free of insect parts.
- 3. If the mesh of the cups becomes stained, wash them by hand with unperfumed soap to avoid odour contamination.
- 4. The residue from cleaning agents may have a repelling effect on the mosquitoes and consequently reduce the catch rate.
- 5. If the catch bag is damaged or torn it should be replaced, as the mosquitoes are able to escape.
- 6. All materials should be put away in clearly marked receptacles or cabinets after each bout of laboratory work.
- 7. All flammables must be returned to the appropriate cabinets.

11.3.2 Preparation

[This section is a draft for the Field Operations Prototype at CPER 2011 and is TBR.]

Prior to pointing:

1. Prepare a batch of triangles using the point punch over a balsa wood (or other malleable) surface.

[Figure 14]

- 2. Press No. 3 archival guality pins into the points equidistant from the three sides at the back of the triangle base. [Figure 15]
- 3. Push the point up the pin until it is 15 mm from the top of the pin. [Figure 16]
- 4. Check the height using the highest hole on a pinning block (for ease of using the collection at a later date).

11.3.3 Sample Processing in the Lab

[This section is a draft for the Field Operations Prototype at CPER 2011 and is TBR.]

- 1. Twenty individuals of each species (representing a range of plots and dates) should be pointed upon return from the Taxonomist.
- 2. Pointing is probably the most widely used method of mounting small dried insects.
- 3. This method consists of attaching the specimen with adhesive (Elmer's white glue) to the tip of a small triangle (archival quality cardstock) (known as a 'point').
- 4. Points are transfixed by a No. 3 entomological archival pins (number refers to thickness of pin).
- 5. Points are cut with a special, standardized triangle-shaped punch.

NEON shall follow the convention of the Walter Reed Biosystematics Unit. This results in mosquitoes prepared with their heads facing left and the legs on the point toward the pin. This can protect the legs from falling off. Pointing is best done under the microscope. [Figure 17]

11.3.3.1 **Pointing mosquitoes**

[This section is a draft for the Field Operations Prototype at CPER 2011 and is TBR.]



To mount a specimen on a point:

- 1. Using forceps, put the mosquito or mosquitoes (it may be easier to do them in batches) on their right side on a slip of plain white paper so that their heads are facing the left and their legs are toward the edge of the bench.
- 2. Slide the slip of paper with the mosquitoes to the center of the microscope stage.
- 3. Take the prepared point and touch the tip of the point in a bit of glue. (Use the minimum amount of glue that will attach the specimen firmly to the point).
- 4. Lift and angle so that the weight of the specimen is leaning directly into the point.
- 5. Place the pin in a block of Styrofoam in a manner that ensures that gravity is holding the specimen to the point.
- 6. Adjust the specimen with forceps or a pin. Adjusting the specimen should cause it to bind firmly to the point. Specimen should be straightened as the glue thickens but before it completely hardens.

Finally, the locality label can protect the specimen. Pointed specimens bisect the type.

When all of the specimens are mounted:

- 1. Examine the specimens under the microscope to see that they are all attached securely to the points.
- 2. To test, place the specimens in a Schmitt box or unit tray.
- 3. Tap the box or tray.

The specimens should remain fixed. A specimen dissociated from its locality label is worthless. Re-attach any specimens (as long as it is clear which is its/their locality labels).

11.3.3.2 Removing a sub-sample for DNA barcoding

[This section is a draft for the Field Operations Prototype at CPER 2011 and is TBR.]

After all of the mosquitoes have been mounted and properly prepared:

- 1. Prepare the 'NEON Mosquito Phenology & Diversity Datasheet' and 96 well microplates so they are within easy reach.
- 2. Apply a unique DNA barcode number to each specimen.

The leg priority for removal for DNA barcoding is as follows: insect's right side midleg, first priority (1), if missing or if opposite leg missing, then foreleg right side, second priority (2), if missing or if opposite leg



missing, then right hindleg (3), if missing or opposite leg missing, left midleg (4), left foreleg (5), left hindleg (6).

- 1. Excise a leg sample from the first specimen.
- 2. Place the tissue sample in the well.
 - [Figure 19]

3. Record the unique number in the 'NEON Mosquito Phenology & Diversity Datasheet'.

DO NOT place any foreign objects (e.g. labels) into sampling wells. Before proceeding to the next sample, ensure that no residual tissue is present on the forceps by rinsing them in 95% ethanol and then flame sterilizing them with an ethanol lamp.

11.3.3.3 Digital Photography

[This section is a draft for the Field Operations Prototype at CPER 2011 and is TBR.]

One photograph of each specimen to be sent for DNA barcoding shall be archived to maintain visual records. This also creates a database of images to use for training. These photos will be taken with a standard Color Separation Guide and Gray Scale, measurement scale and standard camera. These specimens should also be measured and their length recorded (mm) in the 'NEON Mosquito Phenology & Diversity Datasheet'.

Photograph shall be taken with the microscope camera (Leica DM1000 microscope, Clemex Captiva 5.0 camera software).

- 1. Pin the mosquito to a small (approximately 3.5 x 5 cm) Styrofoam block covered with green tissue.
- 2. Pin a second copy of the specimen's unique number label next to the specimen at a height that it will be easily viewed in the photograph.
- 3. Place the 'Color Separation Guide and Gray Scale' near the specimen.
- Orient the specimen under the microscope to get a lateral shot with the head of the specimen facing to the left. [Figure 21]
- 5. Set the magnification as high as possible while still being able to view the whole specimen, its unique number, and the 'Color Separation Guide and Gray Scale'.
- 6. Adjust focus to the highest point at which part of the specimen is still in focus.
- 7. Using the camera software, capture a multi-layer image.
- 8. Prioritize the rear leg and proboscis in the image.



- 9. Choose the 'Capture Multi-Layer' option in the 'Advanced' menu.
- 10. Manually focus through the entire specimen using the fine focus knob on the microscope.
- 11. Change focus as little as possible while still capturing the full depth range of the entire specimen. A progress bar appears in the lower left-hand corner of the image window when the 'Capture Multi-Layer' is initiated.
- 12. Manually click 'Done' once finished focusing through the specimen. This is recommended as the software shuts down if left idle for too long.


After the picture is taken but before it is saved:

- 1. Place a digital image of a scale bar on the bottom right of the image, parallel to long axis of the mosquito as close as possible without obscuring it.
- 2. Activate the 'Scale Line' icon in the task bar of the Image window.
- 3. Change the units used on the scale bar in the 'Options' menu under 'Preferences'.
- 4. Use millimeters.
- 5. Change the number of units that appear on the scale bar by adjusting the number in the 'Scale Line Object Attributes' window that appears when the scale bar is clicked on.
- 6. Change the number of units that appear on the scale bar to 5.

Saving the Image:

- 1. Open a viewer in the Clemex window.
- 2. Click and drag the image into this viewer. This is the only way to save the image with the scale bar.
- 3. Save the image in viewer window.
- 4. Click on the save icon and save the image.
- 5. Save images to the P drive at P:\FSU\Invertebrates\CPER 2011\Mosquito Pictures\unedited. The raw file is named 'culicid' and the unique number of the specimen and then the letter 'r' to indicate it is the raw file (e.g. The uniquely numbered specimen '888', the file name is culicid888r.jpg). Raw files can be accumulated and periodically processed. This and all subsequent file paths should be entered into the 'NEON Mosquito Phenology & Diversity Datasheet'.



11.3.3.4 Processing images

[This section is a draft for the Field Operations Prototype at CPER 2011 and is TBR.]

After the raw image has been saved it must be processed. When editing groups of pictures, copy the original raw files of the group of pictures to be edited and paste them to the edited pictures folder at P:\FSU\Invertebrates\CPER 2011\Mosquito Pictures\edited. Make sure to complete all of the steps below or delete any files that have not been edited from the folder before leaving or changing to a new task.

Batch renaming files, generate a list of current file names in 'edited' folder:

- 1. Open command prompt: Open Run & type in **cmd**.
- Navigate to the P drive within the command prompt: Prompt will show which drive is in use (e.g. if in H drive will say H:\>). To change to a different drive, type the name of that drive (e.g. P:) and hit enter.
- 3. Navigate to desired folder.
- Type in the command cd followed by a space and then the complete file path to the folder containing the pictures to be compressed. (e.g. P:\>cd FSU\Invertebrates\CPER 2011\Mosquito Pictures\edited). Note: to copy and paste into command prompt, short cuts will not work (e.g. Ctrl+V); right click must be used.
- Use the command prompt to generate a list of the file names in the compressed pictures folder: type in the command dir /b *.jpg>list.txt - this will create a text file with a list of the file names in the folder. (e.g. P:\>FSU\Invertebrates\CPER 2011\Mosquito Pictures\edited>dir /b *.jpg>list.txt). Note: spaces are required after dir and b in the command.
- 6. The newly formed text file (list.txt) will be located in the edited pictures folder.

Create an excel spreadsheet to generate commands for new file names:

- 1. Create an excel spreadsheet and save it to the 'edited' folder under the name 'rename'. Label Column A "Original," Column B "New," and Column C "Command."
- 2. Copy the list of file names from the list.txt file into Column A.
- 3. In Column B fill in the new file names, which are made different from the old file names by replacing the r with an e (e.g. culicid2100r.jpg becomes culicid2100e.jpg). The easiest way to do this is to copy the original file names into the second column, highlight the second column, choose replace and replace r.jpg with e.jpg.
- 4. In Column C, paste this formula into C2: **=CONCATENATE("ren ",A2," ",B2).** Fill this formula in for the remaining rows, it should automatically fill the correct values, but check to make sure the formula is filling correctly (A3,B3, A4,B4, etc.)
- 5. Select and copy the cells containing the commands that are desired (i.e. C2:C...)



- 6. Right click in the command prompt, make certain that the correct folder is being used, and paste the commands in and then hit enter. The files should all be renamed
- 7. Open the pictures in Microsoft Office Picture Manager
- 8. Go to edit pictures and crop
- 9. Fix aspect ratio to '4x6'
- 10. Crop out empty space so the images include just the mosquito, the scale bar, color scale and number
- 11. edit all of the pictures and then choose File>Save All when they are finished

Compressing Pictures:

When compressing a group of edited pictures, copy the edited files of the group of pictures to compress and paste them to the compressed pictures folder at P:\FSU\Invertebrates\CPER 2011\Mosquito Pictures\compressed. Make sure to complete all of the steps below or delete any files that have not been compressed from the folder before leaving or changing to a new task.

To batch rename files, generate a list of current file names in 'compressed' folder:

- 1. Open command prompt: Open Run & type in **cmd**.
- Navigate to the P drive within the command prompt: Prompt will show which drive currently in use (e.g. if in H drive will say H:\>). To change to a different drive, type the name of that drive (e.g. P:) and hit enter.
- 3. Navigate to desired folder: Type in the command cd followed by a space and then the complete file path to the folder containing the pictures to be compressed. (e.g. P:\>cd FSU\Invertebrates\CPER 2011\Mosquito Pictures\compressed). Note: to copy and paste into command prompt, short cuts will not work (e.g. Ctrl+V); right click must be used
- Use the command prompt to generate a list of the file names in the compressed pictures folder: type in the command dir /b *.jpg>list.txt - this will create a text file with a list of the file names in the folder. (e.g. P:\>FSU\Invertebrates\CPER 2011\Mosquito Pictures\compressed>dir /b *.jpg>list.txt). Note: spaces are required after dir and b in the command.
- 5. The newly formed text file (list.txt) will be located in the compressed pictures folder.

Create an excel spreadsheet to generate commands for new file names:

- 1. Create an excel spreadsheet and save it to the 'compressed' folder under the name 'rename'. Label Column A "Original," Column B "New," and Column C "Command."
- 2. Copy the list of file names from the list.txt file into Column A.
- 3. In Column B, fill in the new file names, which are made different from the old file names by replacing the e at the end of the file name to c to the end (e.g. culicid2100e.jpg becomes culicid2100c.jpg). Copy the original file names into the second column, highlight the second column, choose replace and replace e.jpg with c.jpg.
- 4. In Column C, paste this formula into C2: **=CONCATENATE("ren ",A2," ",B2).** Fill this formula in for the remaining rows, it should automatically fill the correct values
- 5. Check to make sure the formula is filling correctly (A3,B3, A4,B4, etc.)



- 6. Select and copy the cells containing the commands that are desired (i.e. C2:C...)
- 7. Right click in the command prompt, making sure you are still operating in the correct folder, and paste the commands in and then hit enter. The files should all be renamed
- 8. Open the newly renamed pictures in Microsoft Office Picture Manager
- 9. Select all the pictures by going to the multiple picture view, clicking on the first one, then holding down shift and clicking on the last one. They should all be highlighted when selected
- 10. Go to edit pictures and then Compress Pictures
- 11. Under Compress Pictures, choose Web Pages, then click OK. Once compressed, the thumbnails will have an asterisk in front of the file name







